

OFFICIAL GIVEAWAY TERMS & CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE THE CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

These Official Terms & Conditions (“**Terms**”) govern participation in the giveaway promotion (the “**Giveaway**”). By entering the Giveaway, each participant (“**Entrant**”) agrees to be bound by these Terms and all decisions made in connection with the administration of the Giveaway.

1. SPONSOR AND ADMINISTRATOR

The Giveaway is administered in partnership with **Acquolina** (“**Prize Administrator**”). Acquolina shall be solely responsible for:

- Random selection of the winner(s);
- Coordination and administration of the prize experience;
- Communication regarding scheduling and availability; and
- Fulfillment of the awarded prize.

All decisions made by Acquolina regarding eligibility, winner selection, scheduling, fulfillment, and interpretation of these Terms shall be final and binding.

2. ELIGIBILITY

The Giveaway is open only to individuals who:

- Are at least eighteen (18) years of age, or the age of majority in their jurisdiction of residence, whichever is higher, at the time of entry;
- Submit a valid entry during the promotional period; and
- Are legally permitted to travel internationally if selected as a winner.

Employees, officers, directors, affiliates, agents, contractors, representatives, immediate family members, and household members of the Giveaway organizer, Acquolina, and any associated promotional partners may be excluded from participation where required by law.

Participation constitutes full and unconditional acceptance of these Terms.

3. GIVEAWAY PERIOD

The Giveaway shall begin and end on the dates announced in the official promotional materials (the “**Giveaway Period**”).

Entries submitted outside of the Giveaway Period may be deemed invalid and excluded at the sole discretion of the Giveaway organizer and/or Acquolina.

4. WINNER SELECTION

Winner(s) will be selected **randomly** from all eligible entries received during the Giveaway Period.

The random selection process will be conducted exclusively by **Acquolina**, which shall act as the official party responsible for determining and confirming winners.

Potential winners may be required to:

- Confirm eligibility;
- Provide requested identification;
- Execute prize acceptance documentation; and/or
- Respond within a specified timeframe.

Failure to respond, provide requested information, comply with these Terms, or accept the prize within the required period may result in disqualification and selection of an alternate winner.

5. PRIZE DESCRIPTION

The prize consists solely of the experience, activity, service, reservation, or package specifically described in the Giveaway announcement (the “**Prize**”).

No additional items, upgrades, travel arrangements, accommodations, cash equivalents, reimbursements, or substitute benefits shall be implied unless expressly stated in writing.

Prize value may vary depending on scheduling, availability, seasonality, or other factors.

The Prize is:

- Non-transferable;
- Non-exchangeable;
- Not redeemable for cash; and

- Subject to availability.

Acquolina reserves the right to substitute components of equal or greater value if necessary due to circumstances beyond reasonable control.

6. TRAVEL, TRANSPORTATION, AND VENICE ARRANGEMENTS

The winner acknowledges and agrees that **transportation to Venice, Italy is NOT included as part of the Prize.**

Winner(s) are solely and exclusively responsible for all costs, arrangements, and logistics related to travel to and from Venice, including but not limited to:

- Airfare;
- Train or ferry transportation;
- Ground transportation;
- Hotel accommodations unless otherwise specified;
- Travel insurance;
- Visa requirements;
- Passport documentation;
- Taxes and duties;
- Meals and incidental expenses;
- Personal spending; and
- Any other travel-related costs.

Neither Acquolina nor the Giveaway organizer shall reimburse, arrange, or assume responsibility for transportation expenses under any circumstance.

Failure of the winner to secure transportation or arrive in Venice shall not create any obligation for replacement dates, compensation, refunds, or substitute prizes.

7. SCHEDULING AND AVAILABILITY

Following confirmation of eligibility, **Acquolina will provide the winner with proposed calendar dates and availability windows** for redemption of the Prize.

The winner may select from the dates offered by Acquolina, subject to availability and operational limitations.

The winner acknowledges that:

- Requested dates are not guaranteed;
- Availability may change without notice;
- Blackout periods may apply;
- Certain dates may be restricted due to holidays, events, capacity limits, or operational considerations.

If the winner cannot attend any offered dates, Acquolina shall have no obligation to provide alternative dates beyond those reasonably made available.

Failure to schedule within the designated redemption period may result in forfeiture of the Prize.

8. PRIZE REDEMPTION CONDITIONS

The Prize must be redeemed within the timeframe communicated by Acquolina.

Unused portions of the Prize shall be forfeited and shall not be:

- Refunded;
- Converted to cash;
- Reissued; or
- Transferred to another individual.

No compensation shall be provided for missed reservations, delayed travel, personal conflicts, illness, transportation issues, or inability to attend.

9. RELEASE OF LIABILITY

By participating, each Entrant releases and holds harmless:

- Acquolina;
- The Giveaway organizer;
- Promotional partners;
- Affiliates, subsidiaries, officers, directors, employees, contractors, representatives, and agents;

from any and all claims, damages, liabilities, injuries, losses, expenses, costs, or causes of action arising from:

- Participation in the Giveaway;

- Acceptance or use of the Prize;
- Travel associated with the Prize;
- Scheduling conflicts;
- Transportation disruptions;
- Force majeure events; or
- Any incident occurring before, during, or after redemption.

Participation and travel are undertaken at the winner's own risk.

10. FORCE MAJEURE

Neither Acquolina nor the Giveaway organizer shall be liable for cancellation, delay, rescheduling, modification, or inability to fulfill the Prize due to events outside reasonable control, including but not limited to:

- Weather conditions;
- Natural disasters;
- Public health events;
- Government restrictions;
- Travel disruptions;
- Strikes;
- Venue closures;
- Transportation interruptions; or
- Acts of God.

In such circumstances, Acquolina may modify scheduling or substitute components at its discretion.

11. DISQUALIFICATION

Entrants may be disqualified if they:

- Violate these Terms;
- Provide false information;
- Attempt to manipulate the entry process;
- Engage in fraudulent conduct;
- Harass organizers or participants; or
- Fail to meet eligibility requirements.

Acquolina reserves the right to invalidate entries deemed suspicious or inconsistent with the spirit of the Giveaway.

12. PUBLICITY RIGHTS

Where legally permitted, acceptance of the Prize constitutes permission for Acquolina and the Giveaway organizer to use the winner's name, likeness, image, social media handle, statements, photographs, and related content for promotional, marketing, publicity, and advertising purposes without additional compensation.

13. GOVERNING LAW

These Terms shall be governed and interpreted in accordance with the applicable laws of the jurisdiction designated by the Giveaway organizer, without regard to conflict of law provisions.

Any disputes arising from the Giveaway shall be resolved exclusively through the appropriate courts having jurisdiction.

14. ACCEPTANCE OF TERMS

By entering the Giveaway, each Entrant acknowledges that they have read, understood, and agreed to these Official Terms & Conditions in their entirety and accept that:

- 1. Acquolina is solely responsible for random winner selection;**

 - 4. All travel to Venice, Italy remains entirely the responsibility of the winner and is not included in the Prize.**
